CDBG has disaster recovery funds through the U.S. Department of Housing and Urban Development (HUD). Its purpose is to fund projects that assist in long-term disaster recovery and mitigate the impact of future disasters.

Who does this program serve?

This program awards state grants to local and tribal governments to restore essential community services following declared disasters or emergencies. ERR funds the continuity of essential lifelines that become diminished during an emergency, such as food, water, sewer, power, transportation, communication and shelter.

Housing Trust Fund (HTF)

Who does this program serve?

The Housing Trust Fund provides funding to establish and maintain affordable housing. Properties financed by the program can house people earning less than 80% of the Area Median Income, but most of these properties house households with special needs or incomes below 30% of the Area Median Income. This includes people and families experiencing homelessness, people needing supportive housing, seniors, veterans, farmworkers, and people with developmental or other disabilities.

On Dec. 18, Gov. Ferguson directed funds to the HTF to support people impacted by flooding in Washington. Homeowners who have families with children aged five or younger, senior citizens and veterans will be prioritized when awarding grants. Ferguson plans to make this early action legislation heading into the upcoming session.

Who does this program serve?

Manufactured/mobile home communities in Washington that are closing or converting to a use other than a manufactured/mobile home community may be eligible for assistance for relocation or demolition services. "Closure" includes communities permanently closed due to "health and safety concerns" (for example, flooding, landslides, etc.). Households must meet income guidelines (below 80% AMI) and must be owner-occupants of either a manufactured or mobile home at the time of the closure notice.

For households displaced as a result of "health and safety concerns," such as flooding, Commerce must receive documentation from a regulatory entity that demonstrates the health and safety reasons for the permanent closure of the manufactured/mobile home community or mobile home lot.
